To whom it may concern

1. You are receiving this formal notice as the representative of the above-mentioned defaulting person or entity in that the policy of the defaulting person or entity to make testing and/or vaccination for or of COVID-19, or any other disease, mandatory in respect of the premises concerned (e.g. retirement village, sectional titles scheme, preschool, flats, shopping centre, shopping mall). This is discriminatory towards my freedom of expression, my right to opinion and it infringes on my right to bodily integrity, but it is also in direct violation of international law, *Article 6(1) of the UNESCO Universal Declaration on Bioethics and Human Rights, 2005*.
2. Any preventive, diagnostic and/or therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information provided. This consent should, where appropriate, be express and may be withdrawn by the concerned person at any time and for any reason without disadvantage or prejudice.
3. Any future choice to potentially refuse to be vaccinated or tested, for any cause whatsoever, may not lead to any form of discrimination committed against me as defined in the Promotion of Equality and Prevention of Unfair Discrimination Act, 2000 (Act No. 4 of 2000), also prohibited in terms of the Consumer Protection Act, 2008 (Act No. 68 of 2008).
4. In consequence of the afore, any regulation, order, instruction or similar, instituted by the entity concerned, violates my rights under South African and international law.
5. You are hereby notified that you and/or the entity concerned, are to conduct a proper investigation into subject matter of this *bona fide* disclosure and that you and/or the entity concerned are to report back to me within a period of not more than 7 days from date of this notice.
6. As the representative of the defaulting person/entity you are required to, in writing, acknowledge receipt of the disclosure by informing me of the decision –
 - a) to investigate the matter, and the time period in which the investigation will likely be completed; or
 - b) not to investigate the matter and the reasons for such decision; or
 - c) to refer the disclosure to another person or body.

7. Kindly note that as a result of me having made this *bona fide* disclosure of discrimination, I may not face any retaliation which includes, for example, termination of an agreement, eviction, any intimidation, or the threat thereof, *et cetera*.
8. The defaulting person/entity is further notified that if I am in any way subjected or may be subjected, to any further discrimination, or anyone acting on my behalf, may approach any court having jurisdiction, including the Equality Court, for appropriate relief; or pursue any other process allowed or prescribed by any law.
9. In the event that discrimination may be further committed against me for having made this *bona fide* disclosure, I hereby appoint **Liberty Fighters Network (LFN)**, to be my lawful representative organisation to pursue this matter further, either in a court having jurisdiction or other forum, against the defaulting person/entity on my behalf and to do everything required in law to protect my non-negotiable human rights and to claim on my behalf any damages I might directly or indirectly suffer as a result of the discrimination committed against me.
10. I am willing to, at the expense of the defaulting person or entity, receive professional guidance from any registered health practitioner or nurse in respect of both advantages and disadvantages of being vaccinated and/or tested and inform that it will remain my own free choice to accept or not to accept such advice.
11. Meanwhile, I further choose to not undergo any test for COVID-19 or any other illness, unless I am advised by my own chosen medical practitioner to be tested or an order of court legitimately obtained directs me to be tested. In the event that I am being denied access to the premises on the grounds of me refusing to be vaccinated or tested, the defaulting person or entity will remain responsible for my full entitled benefits for such period I am denied access as a result of such refusal of entry and will be held liable for damages so incurred.

In the event that the defaulting person or entity fails to adequately respond within these 7 days, I will accept in good faith that the defaulting person or entity will not proceed to force me to be vaccinated and/or tested in order to comply with its orders, instructions, regulations or similar. In this event I will accept in good faith that this matter had been sufficiently dealt with.
15. My rights remain reserved in full.
